An International Baccalaureate (IB) World School, IGBIS was the first school in Malaysia authorised for the full continuum of IB programmes: the Primary Years Programme (PYP), the Middle Years Programme (MYP), the Diploma Programme (DP), and the Career-related Programme (CP). IGBIS is the only school in Malaysia accredited by the New England Association of Schools and Colleges (NEASC) and is also a member of the Association of International Malaysian Schools (AIMS), the East Asia Regional Council of Schools (EARCOS), the Council of International Schools (CIS) and Next Frontier Inclusion.

An IB education aims to develop inquiring, knowledgeable and caring young people who help create a better and more peaceful world through intercultural understanding and respect. This philosophy underpins the curriculum, co-curricular and after-school programmes at IGBIS with the aim of inspiring students to become principled, global citizens. IGBIS is committed to providing high-quality international education for our students in an inclusive learning community where they participate in a challenging, caring and holistic educational experience.

The **MYP Service as Action Coordinator** is responsible for designing, implementing, and managing the Service as Action program within the MYP framework. This role supports students in Grades 6–10 to identify, plan, and carry out meaningful service activities that reflect the IB's mission to create responsible and caring citizens. The coordinator will work closely with students, teachers, parents, and community partners to ensure students can connect their learning to real-world applications, fostering empathy, responsibility, and lifelong service-oriented values.

Key Responsibilities

1. Program Development and Implementation

- Develop, plan, and implement the Service as Action program in alignment with the IB MYP requirements and school goals.
- Establish clear objectives and expectations for service projects at each grade level, ensuring they align with the IB Learner Profile attributes and support meaningful student engagement.
- Develop resources, tools, and guidelines to support students and teachers in planning and conducting service activities.

2. Student Engagement and Support

- Guide students in identifying service opportunities, setting goals, planning projects, and reflecting on their learning.
- Provide support, advice, and supervision to students throughout their service projects, ensuring safe, ethical, and impactful involvement.
- Facilitate workshops and advisory sessions on service learning, community engagement, and reflection strategies.

3. Collaboration with Faculty and Staff

- Work with subject teachers and MYP mentors to integrate service opportunities into the curriculum, enhancing interdisciplinary connections.
- Train and support teachers to help them incorporate service as action into their teaching practices, including understanding reflection processes.
- Collaborate with the MYP Coordinator to ensure that the Service as Action program supports the holistic goals of the MYP.

4. Community and Stakeholder Engagement

- Build and maintain relationships with local community organizations, NGOs, and other potential service partners to facilitate meaningful opportunities for students.
- Communicate regularly with parents and guardians to encourage understanding and support of the Service as Action program.
- Organize events, presentations, and exhibitions where students can showcase and reflect on their service achievements.

5. Monitoring, Assessment, and Reporting

- Track student progress in meeting Service as Action requirements, ensuring compliance with IB standards.
- Evaluate the impact of service activities on student learning and personal growth through regular reflections, journals, and project assessments.
- Prepare reports and maintain records to provide feedback to students, teachers, parents, and the MYP Coordinator on student engagement and program outcomes.

6. Training and Professional Development

- Participate in IB workshops and other professional development opportunities to stay updated on best practices in service learning.
- Lead professional development sessions for staff on the Service as Action component and on supporting students in reflective practices.
- Continuously review and improve the program to reflect new research, IB updates, and feedback from the school community.

- Have degree-level qualifications in their subject area

Related Experience

- A minimum of 3-5 years of teaching experience, preferably in an IB or similar international educational setting, is often expected.
- Prior experience in a leadership role, such as a Subject Leader, Coordinator, Head of Department, or a similar position, may be preferred.

- Strong understanding of the IB MYP framework, specifically the goals and expectations of the Service as Action component.
- Proficiency in developing and implementing a comprehensive curriculum that aligns with IB standards and practices.
- The ability to lead and inspire a team of educators, as well as to facilitate professional development and mentorship.
- Proficiency in developing and implementing a comprehensive curriculum that aligns with IB standards and practices.
- The capacity to analyze student performance data, curriculum effectiveness, and educational resources to make informed decisions and improvements.
- Strong oral and written communication skills to effectively convey concepts and ideas to students and teachers.
- The ability to collaborate effectively with teachers, administrators, and parents to support the program.
- Excellent organizational abilities to manage curriculum presentations, resources, budgets, and professional development initiatives efficiently.
- Flexibility to adapt to evolving educational practices and IB guidelines.
- Proven problem-solving skills to address challenges and take initiative to resolve them.
